Buyback of own shares – 53rd interim notification

In the period from 23 January 2017 until and including 29 January 2017 a total of 63,789 shares were purchased within the scope of the share buyback. Notice of commencement of this share buyback on 11 January 2016 was given by publication on 7 January 2016 pursuant to Art. 4 para. 2 of the Regulation (EC) no. 2273/2003.
